A RESOLUTION OF THE GLENEDEN SANITARY DISTRICT AUTHORIZING CERTIFICATION TO THE LINCOLN COUNTY TAX ASSESSOR OF DELINQUENT SEWER USER FEES

WHEREAS, Gleneden Sanitary District is a Special District organized and operating under ORS Chapter 450 and a local of unit government as set forth in ORS 174.116; and

WHEREAS, the District charges user fees for use of its sanitary sewage system but has no authority or ability to collect sanitary sewage disposal charges in connection with or as part of another service or utility that can be curtailed to secure collection; and

WHEREAS, ORS 454.225 authorizes Municipalities as defined in ORS 454.205, which includes sanitary districts, to certify delinquent sanitary sewer charges owed to the District to the Tax Assessor for Lincoln County for inclusion in the 2023-24 property tax levy; and

WHEREAS, the Board of Directors has determined that the delinquent charges set forth against the properties below are due and owing and should be so certified to the Tax Assessor and being fully advised
